### Clarification of Emergency Declarations

After monitoring current conditions with the Coronavirus and out of an abundance of caution for the community, city staff and their families, several facilities for the City of Brady will be closed to the public or will have restrictions in place to limit public interactions and the potential spread of the virus. Beginning on March 17, 2020, City Hall will be closed to the public. All staff will be in place and will be available by phone and email to assist the public. The phone number to City Hall is (325) 597-2152 and emails for city personnel can be found on our website at [www.bradytx.us](http://www.bradytx.us).

Utility customers may make payments via mail, online, by phone or in the drop box located in the drive-thru outside of City Hall. Payments will be continuously collected from the drop box during business hours. If you are a cash customer, please do not drop payments off outside of the hours of 8:00 a.m. through 5:00 p.m. If exact cash is not provided, you will see a credit for the overpaid amount on your next utility bill. Change will not be issued. If you are needing to submit an application for new services, please contact our Customer Service department at (325) 597-2152.

Beginning Wednesday, March 18, the Sunset Senior Center will be closed for public activity. Meal delivery will continue and to-go meals will be prepared for customers from 11:30 a.m. until 12:15 p.m., during normal meal service hours. Customers are asked to pull to the back of the center, near the kitchen, so that staff can serve customers more quickly. Although not required, customers can call in advance to place an order at (325) 597-2946.

The City of Brady Municipal Court will not hold court this month. Individuals with a court date and/or with outstanding fines are encouraged to contact Municipal Court at (325) 597-2156 or pay online at <https://www.municipalonlinepayments.com/bradytx/court/search>. Notices with a new court date will be mailed once a new date is set.

The City Service Center will have restricted access. Should you need to apply for any permitting, please call (325) 597-2244 before traveling to the service center for assistance.
